New Ordinance added at last council meeting

An ordinance adding new language to the code of ordinances of the Town of Drummond relating to the parking and use of travel trailers or motor homes on lots occupied by a free-standing residential dwelling.

New language. The following language was added to the code of ordinances of the Town of Drummond in Chapter 12, Article 5, as section 12-43.

Section 12-43. use of Mobile Homes, Travel Trailers, Campers, or Recreational Vehicles on Residential Lots

No mobile home, travel trailer, camper, recreational vehicle, or other types of mobile unit designed to be used as living quarters may be occupied other than temporary purposes on any residential lot that also has a freestanding residential structure located thereon. As used in this section, temporary use shall be for 10 or fewer consecutive overnight stays with a separation of at least 5 days between periods. Any vehicles subject to this section must be parked behind any building setback lines on residential lots.

CODE ENFORCEMENT

With nicer weather and rain, weeds and grass grow very quickly! This is just a friendly reminder that you will get flagged for weeds and grass over 12 inches in height. Once you are flagged you have 10 days to correct it, or you could receive a citation for failure to maintain property.
